Dear Fellow American,

Have you heard about the "Amero" or "Totalization" or "North American Union" or "NAFTA Superhighway"?

These strange words may soon become household names in the United States -- unless you and I rise up and say, "No! We will not permit the peddlers of such alien notions to change the America we love."

"Amero" is the name of the new currency planned to replace our U.S. Dollar when it is merged with the Mexican peso.

"Totalization" is the buzz word to put illegal aliens into our Social Security System on better terms than U.S. citizens get -- which will bankrupt the system when baby boomers retire.

"North American Union" is the plan to open our northern and southern borders so there will be free movement of goods, services, money, and people between the United States, Canada and Mexico. There'll be no need for smugglers any more -- all aliens can come in.

"NAFTA Superhighway" is the giant toll road that will bring slave-labor products from China through a Mexican port and up into heartland America, where they will destroy our remaining manufacturing jobs.

What is going on?

Let me tell you. The globalists are trying to make American workers compete in a global economy against Third-World wages of 30 cents an hour -- and make U.S. taxpayers provide Social Security benefits for illegal aliens.

This is being done without any law passed by Congress -- without any treaty ratified by the Senate -- without any public hearings. It's done by press releases and executive orders.

These plans will destroy American freedom, Constitution, prosperity, and standard of living. I am more afraid for the future of our great nation than ever before because powerful people are pushing these bad policies. That's why I need your immediate help and financial support.

Let me give you the facts.

In Waco, Texas on March 23, 2005, President Bush met with Mexico's President Vicente Fox and Canadian Prime Minister Paul

Martin, and then issued a press release committing us to a "Security and Prosperity Partnership of North America" (SPP), with "Working Groups" to write the details.

Two months later, on May 17, 2005, the powerful Council on Foreign Relations (CFR) issued a 59-page document outlining a 5-year plan for the "establishment by 2010 of a North American economic and security community" with open borders so that people and goods can "flow freely" between the three countries.

This CFR document linked the goal of a North American Community to Bush's SPP, and even **demande**d that the United States "implement the Social Security Totalization Agreement negotiated between the United States and Mexico."

One month later, on June 27, 2005, Homeland Security Secretary Michael Chertoff went to an SPP meeting in Ottawa, Canada, to "facilitate the flow of traffic across our borders." (Maybe that's why Chertoff is trying to avoid building the border fence ordered by Congress in the Secure Fence Act.)

Then, on March 31, 2006, President Bush met in Cancun, Mexico, with his Mexican and Canadian friends to celebrate the first anniversary of the Security and Prosperity Partnership.

Meanwhile, 20 Working Groups of the three countries have been quietly operating in the U.S. Commerce Department. They are re-writing our Administrative Law regulations to make them agreeable to Canada and Mexico. These new regulations are not submitted to Congress or to the American people.

It's pretty clear, isn't it, why President Bush won't stop illegal aliens from coming over our southern border! He wants North American economic integration and open borders, and his corporate friends want cheap labor.

That's why President Bush is still pushing Congress to pass some version of the Kennedy-McCain bill calling for amnesty for illegal aliens and bringing in more millions falsely labeled "guest workers," and making them eligible for U.S. Social Security benefits. You and I cannot allow this to happen!

"Totalization" is one of the biggest rip-offs of U.S. taxpayers that anyone has ever proposed. Because of a Freedom of Information lawsuit, we just learned the details of Bush's plan to put illegal aliens into our Social Security system.

Americans must work 10 full years to be eligible for Social Security benefits, but Totalization would enable illegal aliens to get benefits after only 18 months of work in the U.S. The horrendous cost of this plan will bankrupt Social Security when baby boomers retire.

The NAFTA Superhighway will not be a new interstate to accommodate Americans. It will be a tollroad (bypassing cities) to bring slave-labor products from China in sealed containers direct from a Mexican port to Kansas City, Missouri, where Mexico will operate the customs facility.

China will be the big winner of the NAFTA Superhighway! The tolls will be collected by foreigners! The contract for the segment from Mexico to Oklahoma, called the Trans-Texas Corridor, has already been signed with a Spanish company. Cintra Concesiones de Infraestructuras de Transporte, S.A. bought the right to operate it as a 10-lane tollroad and collect tolls for the next 50 years.

Remember the uproar when we heard about the proposed sale of 22 of our port operations to Dubai Ports World, a Middle East company? "We the people" got the sale cancelled!

But the sale to foreigners of our infrastructure is going ahead every day, right under our noses, with almost no publicity. Foreign companies will be collecting tolls for 99 years on Virginia's Pocahontas Parkway, for 75 years on the Indiana Toll Road, and for 99 years on the Chicago Skyway.

Is America for sale?

Please sign the enclosed petition to Senate Minority Leader Mitch McConnell urging him to oppose all plans to let President Bush's SPP grow into a "North American Community," or to replace the U.S. dollar with the Amero, or to let U.S. regulations be re-written by Canadian and Mexican "Working Groups."

America must not go down the European road, where globalization, open borders, and economic "integration" led to giving up their sovereignty to a European Union run by unelected bureaucrats in Belgium and judges in Luxembourg.


